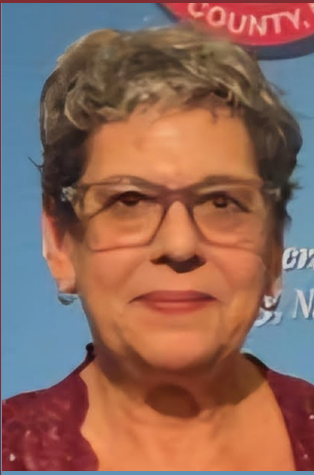

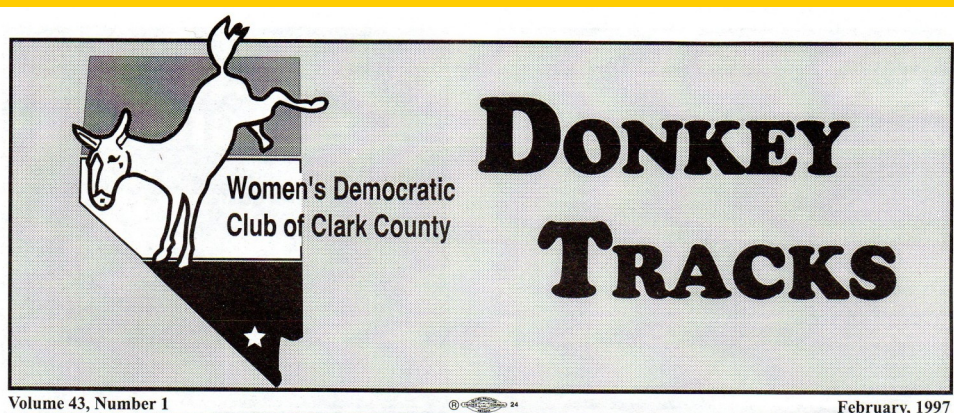
# 1997 Repeats Itself in 2026

# OPINION: Berkley Enjoys A Perfect Final Act In Nevada Politics — But She's Not Done Yet

*As mayor of Las Vegas, the longtime political dynamo is hardly resting on her laurels as she sets her sights on tough city issues.*

The black-and-white photo hangs in a place of honor inside Las Vegas Mayor Shelley Berkley's office and speaks to a different era of Democratic Party politics in Nevada.

For one thing, it shows four Democrats actually laughing. When's the last time you saw that happen?

The picture was taken in the late 1980s, which I don't remember as a bust-a-gut decade for Democrats. But the moment of levity is captured

right there on the wall at City Hall.

The camera catches Berkley in the fast company of the state party's legendary three amigos: Sens. Harry Reid, Richard Bryan and Rep. Jim Bilbray. The prankster Bryan sticks out his tongue, the squinting Bilbray snickers. The senior Reid, no Henny Youngman on the stump, is practically grinning.

And there's the smiling Berkley, the former Strip cocktail waitress and UNLV student body president who served a term in the Assembly before winning a seat on the Board of Regents. She served throughout the tumultuous 1990s with the same academic chip on her shoulder that her friend former Regent Bilbray had when he fought for a [fair share of funding](#) for Southern Nevada's fast-growing UNLV.

These days, most people probably know Berkley best as a former six-term member of Congress, who [narrowly lost](#) in 2012 to incumbent Sen. Dean Heller (R). After suffering what she calls a political heartbreaker, she admits in a recent interview, "I had no idea what I was going to do with the rest of my life, and it actually turned out to be the best thing that could have possibly happened to me."

Berkley spent most of the next decade as [CEO and senior provost](#) of Touro University's Western Division, a private medical school system that includes a campus in Henderson. She enjoyed the work and could have retired there with no regrets — not about her years in the House, that stinging Senate loss or any of it.

But remaining on the sidelines was never Berkley's style, and entering her early 70s didn't change that. Her decision to reenter politics with a run for mayor came as little surprise to those who know her.

With Las Vegas Mayor Carolyn Goodman term-limited after a whopping 13 years in office, Berkley defeated Councilwoman Victoria Seaman in 2024. The mayor's job is officially nonpartisan, but Berkley has always worn her politics on her sleeve.

"As much as I loved Touro, I like being in office and doing work for the public," she says. "I never wanted to go D.C. again, and I never wanted to go to Carson City again. And now I'm mayor of Las Vegas, and I get to sleep in my own bed at night.

"And I think, oh, thank heavens. Because if I was back there in D.C. now, I would be ready to pull my hair out of my head."



She is not alone in that frustration, of course. The question, one that defines the office she holds, is what can a mere mayor do about it?

In a strong-manager form of government, the mayor's official duties are akin to being a member of the Las Vegas City Council with senior ribbon-cutting privileges. In practice, as the Goodman city hall dynasty illustrated, the job comes with a high-octane bully pulpit thanks to the international profile of Las Vegas. Geographical nitpicking aside, no one cares that the city limits don't include what the world knows as the Las Vegas Strip.

At a time when many Las Vegas leaders were silent and staring at their shoes, [Berkley was outspoken](#) about the damaging effect of President Donald Trump's economic chaos and dizzying tariff threats against our longtime trading allies. Trump's alienation of throngs of loyal Canadian tourists and other international travelers to Las Vegas made everyone's job harder. While gaming industry titans were experiencing selective deafness, the mayor pointed out the obvious.

Berkley remains concerned about the administration's aggressive immigration policies and use of masked federal agents and U.S. military personnel in roundups. It doesn't take a marketing maven to surmise that glorified goon squads and National Guard troops are a bad look in an ethnically blended tourist city.

"Right now, our biggest challenge is the feds, and I'm doing everything I can to keep them out of Southern Nevada," Berkley says. "The last thing I need with a soft economy is the National Guard walking down Fremont Street. I think this current administration is perfectly capable of finding a reason to come in here and be very disruptive, which would have very devastating consequences for this city. That is paramount on my mind, to be perfectly candid."

Does it sound like she's taking this personally? It should.

Berkley comes from a family that made its living on the floor of the gaming industry. Her late father, George Levine, was a storied showroom captain and maître d', and she remains proud of her early days schlepping cocktails to slot players and high rollers alike. When she promotes local businesses in the downtown corridor, including talking up traditional Vegas come-ons such as cheap shrimp cocktails on Fremont Street, she sounds authentic.

Berkley's visions for improving the city are complicated by Trump's chaotic economy and the [stinging \\$286 million settlement](#) of the Badlands Golf Course litigations that coincided with the start of her term. The city was forced to trim staff, tap general fund and liability fund reserves, delay capital improvements and jettison Cashman Field to resolve its legal fight with developer Yohan Lowie.

With her legislative experience and Washington contacts, Berkley appears well-positioned not only to raise the mayor's profile, but also its impact on the complex issues facing Las Vegas and other metro areas.

She's experienced the recurring themes that have haunted Nevada's quality of life for generations. In our brief interview, she reels off a litany of trouble spots and perennial challenges. From encouraging transportation options to improving health care and public education, she reminds a skeptic, "You get what you pay for."

"Ever since I served in the Assembly in 1983, we've been talking about economic diversification," Berkley says. "You need a strong education system to accomplish that. I'm having the same conversation that we had 40 years ago, and we still haven't done what we need to do to truly diversify our economy."

Reminded of the limits of the office and gavel, she responds, "The big issues aren't within my responsibility, but I have a bully pulpit and I talk about these issues a lot."

She calls her relationship with Clark County Sheriff Kevin McMahon professional and productive, and expresses relief to have reached an accord with the community's animal rights activists over [pet store sales](#), a surprisingly political issue in Southern Nevada.

Then there's the issue that can't be hidden: the increasing impact of homelessness on the community.

"The biggest challenge I have is homelessness," Berkley says. "Human beings should not be on the street. It's a humanitarian crisis. It's dirty, it's unhealthy, it's dangerous and I don't want to create an environment that we're sustaining people on the street. I want to create an environment where we are dealing with the root causes of homelessness — mental health, addiction, a lack of job training — and do whatever we can do to help people that are living on the street become self-sustaining and able to care for themselves and their families. It's a very, very huge challenge."

And Shelley Berkley's only a mayor.

In the final act of her long political career, it's her turn to try to do something about it.

## **WHAT IS AHEAD IN 2026?**

**Leaving an Awful Year Behind**

**Can we be hopeful that by maintaining our strength,  
possibly aided by a “miracle,” a degree of normalcy will return in 2026?**

**As 2025 draws to an end, there is no doubt that most of us would have never perceived the rapid decline into wannabe authoritarianism we have witnessed on a daily basis. Just as we think it can't possibly get any more bizarre, it does.**

# The Great Betrayal: How a U.S. Envoy Helped Russia Shape a Plan Against an American Ally

*A U.S. envoy coached a senior Russian official on how to influence an American president into embracing a plan that advantaged an aggressor and weakened an ally fighting for its survival as a sovereign state.*

*A betrayal rarely arrives as a dramatic gesture. It accumulates through process—through choices that elevate an adversary's interests while diminishing those of an ally, through private conversations that displace public commitments, through the quiet reordering of whose voice is heard first and whose is heard last. What occurred in October 2025 was neither an ideological shift nor a sudden rupture. It was something more deliberate: the migration of American power away from an ally fighting for survival and toward the autocrat attacking it.*

On October 14, as Bloomberg reported, Steve Witkoff, the newly appointed special envoy, placed a five-minute call to Yuri Ushakov, Vladimir Putin's senior foreign-policy adviser. He did not present an American position or outline U.S. red lines.

Instead, he coached Ushakov with an ease that would have been notable even in peacetime. According to the Bloomberg recording, Witkoff offered no deterrent message. Rather, he advised a senior Russian official on how best to flatter and influence an American president whose sensitivity to praise has been extensively documented in U.S. and foreign reporting. He urged Ushakov to schedule the call before President Volodymyr Zelensky's October 17 White House visit, ensuring that Moscow—not Kyiv—would reach President Donald Trump first. He proposed beginning with congratulations on the Gaza agreement, describing Trump as a “man of peace,” presenting Russia as cooperative, and invoking the “20-point” Gaza plan as a model. He even encouraged Putin to reference earlier “Steve and Yuri” conversations to signal rapport.

This guidance did not come from Moscow's political operatives. It came from a U.S. envoy—advice that helped an adversary prepare for a conversation with the American president at a moment when Ukraine depended on U.S. backing for its survival.

In American diplomacy, envoys do not serve as communications consultants to foreign leaders, especially not to adversaries engaged in active war. AFSA guidance, State Department protocol, and the White House's “One Voice” doctrine all define envoys as extensions of the Secretary of State, charged with advancing U.S. policy rather than refining an adversary's messaging.

Yet a U.S. envoy prepared a Kremlin adviser for a call with the American president before America's ally had even been heard. In alliance politics, sequencing is not ceremonial; it determines influence. The first speaker sets the frame; the second must work within it. By advising Russia on timing, tone,

and approach—by helping an adversary craft a calibrated appeal to a president whose reaction to praise is a matter of public record—Witkoff granted Moscow advantages alliances normally reserve for partners. Ukraine—under attack and reliant on American military and intelligence support—entered the conversation only after the adversary had already shaped its outline.

This inversion was not procedural noise. It was, in operational terms, a form of betrayal: an American envoy equipping an adversary to shape his own president's perceptions while the ally under attack received no comparable preparation in a moment that cannot be replayed—the initial framing that guides all subsequent decisions.

Two days later, as *Bloomberg* documented, Putin followed the guidance closely. He opened his two-and-a-half-hour call with Trump using the congratulatory tone, Gaza framing, and conciliatory posture Witkoff had outlined. The overlap between the coaching and Putin's talking points was unmistakable in the recorded evidence.

Within days, *Axios* and *Bloomberg* reported that Witkoff met in Miami with Kirill Dmitriev, head of Russia's sovereign-wealth fund and long identified by the Senate Intelligence Committee as a Kremlin-linked backchannel to Trump-aligned networks. By month's end, *Axios* reported that Dmitriev and Ushakov were discussing how far Russia should press its "maximum" terms.

This was not coincidence. It was structure.

Dmitriev is a Kremlin-designated backchannel operator; Ushakov is Putin's top foreign-policy aide. Both participated before Ukraine saw anything resembling a plan. The pattern was unmistakable: the adversary brought into the room early, the ally relegated to reacting after the framework had already taken shape.

The result was a shift in negotiating power toward the aggressor—before the victim state had been invited to the table.

Ukraine eventually received a 28-point peace proposal—unsigned, unattributed, and far from what Kyiv expected from a major ally. AP and *Axios* reported that the language displayed hallmarks of Russian bureaucratic drafting: legalistic verbs, administrative cadence, and syntactic patterns associated with Russian state memoranda rather than American diplomatic documents. Ukrainian officials recognized these features immediately. The text did not resemble something produced in Washington. It resembled something shaped in Moscow.

The damage lay not only in authorship, but in form.



A peace proposal is a trust-bearing document: an ally offers it to safeguard another's sovereignty. Here, Ukraine received a plan labeled as American—expected from the country supplying its weapons and intelligence—only to discover linguistic traces of the state invading it.

This was not a minor irregularity. It was a procedural breach: Ukraine received, under an American banner, the conceptual architecture of the aggressor—a plan demanding concessions and long-term constraints that originated not in Washington but in consultations with the invading state. Few signals could more deeply erode confidence than a document bearing an ally's label and an adversary's fingerprints.

This is why the proposal alarmed Ukraine and Europe. It was not only the terms. It was the realization that the voice inside the document did not sound like Washington's.

When Ukraine examined the plan, it found demands that, according to AP, *Axios*, *The Guardian*, and Politico Europe, would formalize Russian territorial gains without requiring Russia to withdraw or disarm. The proposal required Ukraine to recognize Russia's control over Crimea, Luhansk, and Donetsk; withdraw from additional territory Russia had not taken by force; accept frozen front lines in Kherson and Zaporizhzhia; renounce NATO membership; and limit its troop levels and long-range weapons. Russia, meanwhile, faced no reciprocal force caps, no withdrawal, and would receive phased sanctions relief.

These provisions were not theoretical. They would have redrawn Europe's map, weakened Ukraine's capacity to defend itself, and rewarded Russia's invasion in concrete terms. They would codify gains achieved by force while constraining only the victim.

Perhaps most revealing were the proposed "security guarantees." AP reported that they were non-binding, dependent on the political choices of future U.S. administrations, and voidable if Ukraine used certain U.S. weapons. Ukraine was being asked to trade territory and sovereignty for assurances the United States could reverse easily.

The historical record—Helsinki in 2018, the 2019 Ukraine aid pause, public statements suggesting NATO allies deemed "delinquent" might be left vulnerable, and the 2025 suspension of military and intelligence support—shaped how Kyiv evaluated those guarantees. These events, reported by CBS, PBS, AP, UPI, and the Senate Intelligence Committee, formed the context through which small states assess reliability.

# Pardon The Corruption

Trump's justification for invading American cities and other countries is to reduce the crime he is actively encouraging through his pardons.

The President of the United States has said that preventing the flow of drugs from South America into the U.S. is a national priority. On that basis, the U.S. military is killing alleged drug traffickers without due process. It is also preparing to invade Venezuela. Trump says the leader there is involved [in narcoterrorism](#), justifying the extraordinary step of war.

But if Trump is opposed to drug trafficking from south of the border, why did he [just pardon](#) another leader in the region who was part of a massive drug trafficking ring? Juan Orlando Hernández, the former President of Honduras, was tried and convicted of exactly the accusations that Trump is using to drum up a pretext for war against Venezuela. Hernández was convicted of receiving millions from violent drug gangs for facilitating the flow of 400 tonnes of cocaine into America, while corrupting state institutions.

A prosecutor reported that Hernández boasted to drug dealers that "together they were going to shove the drugs right up the noses of the gringos." An agent who worked the Hernández case [said](#): "It means any attempt to work your investigations to the highest levels is meaningless."

Trump is also invading Democratic cities with military or paramilitary forces. His justifications for their presence is to improve public safety and enable his immigration sweeps. Trump officials label [protests](#) of federal officials in Democratic cities as "insurrection," justifying the federal presence.

But if Trump was interested in law and order, why does he keep pardoning criminals? While many of those criminals are white collar, he has also pardoned violent convicts. Of the nearly 1,600 Capitol insurrectionists pardoned, more than 200 of these were convicted of assaulting law enforcement officers. [Many](#) of those pardoned by Trump have gone on to commit crimes.



In one especially grim case, a child molester [tried to silence](#) his victim by promising a share of reparation money he expected to be paid by the Trump administration.

Let's take a closer look at how Trump has used his pardon powers for corrupt purposes.

## **Pardon Abuse**

The pardon power is a weird [constitutional inheritance](#) that mostly draws attention when it is abused. (In this post, I am going to treat pardon, clemency, and commutation as broadly falling under the category of pardon powers, though they have distinct legal effects).

Over time, Presidents sought to minimize the risk of abuse by making it more consistent with the ideals of a Weberian bureaucracy: transparent, impartial, and subject to clear criteria. This has given way to a reliance on leveraging of political connections and appealing to Trump's personal whims. The use of pardons is now consistent with Trump as "a king above the law" in Justice Sotomayor's memorable framing.

The pattern of extreme politicization of the pardon process began in Trump's first term. William Barr, Trump's former Attorney General [said](#) "there were pardons being given without any vetting by the department." One [analysis](#) found that only 11% of Trump's 238 first term pardons went through the formal DOJ review process.

Things have gotten even worse in his second term, partly because of Trump's broader indifference to norms, but also because he has installed Ed Martin to oversee the process. Martin is the first partisan political appointee to lead the Office of Pardon Attorney, which was previously manned by career civil servants.

DOJ lawyers normally apply standard [criteria for pardons](#), these include: post-conviction conduct, character and reputation; seriousness and relative recentness of the offense; acceptance of responsibility, remorse, and atonement; and need for relief. The ideal case was someone who had served significant time, especially for more serious crimes, expressed remorse, and faced real hardship because of their conviction. Now, the ideal case is a wealthy supporter of the President who would prefer never to see the inside of a jail cell for their crimes.



According to [ProPublica](#):

For those who followed the standard protocol set out by the Department of Justice, the sense is growing that the process no longer matters; they've watched the public database of applicants swell with thousands of pending cases, while Trump grants pardons to people who never entered the system at all.

Presidents could and sometimes did ignore DOJ recommendations or worked outside of the formal process. Most notoriously, on the last day of his presidency, Bill Clinton pardoned Marc Rich, a white-collar fraudster living in exile, after his wife made large contributions to the Democratic party and Clinton's presidential library. We could see this as a precedent for Trump's actions, but not a justification. The pardon triggered an FBI investigation, and was enough of a scandal that Clinton expressed remorse. Similarly, Joe Biden bypassed the review process to issue a pardon to his son, Hunter Biden. The decision drew much criticism, but the logic — that Trump would weaponize the legal system to attack his family — is increasingly hard to disagree with. Trump has repeatedly said he will void such pardons.

The bureaucratic process for reviewing pardons minimized the potential for the type of broad corruption we are seeing now. Abuses of the system were considered scandals, aberrations from the norm. Now the aberrations are the norm. Martin has proudly politicized the pardon process, posting "No MAGA left behind" on his social media after Trump pardoned a supporter convicted of taking bribes while serving as a sheriff.

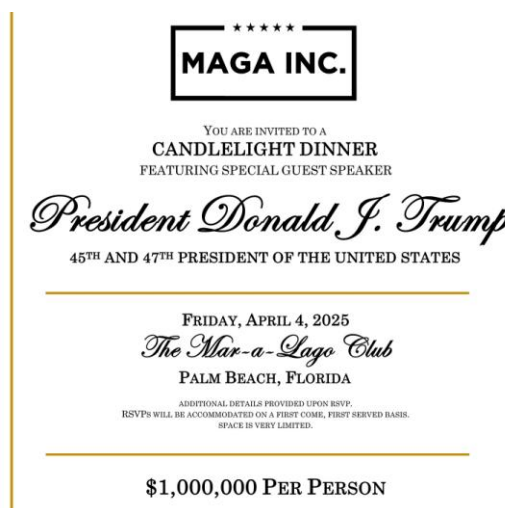
### **Pardoning Loyalists and Supplicants**

Trump accepts two primary types of currency for his pardons: loyalty and money.

In addition to the January 6 insurrectionists, Trump has pardoned 77 people who sought to overturn the 2020 election on his behalf, [including](#) slates of alternate electors, legal guides, and those who promoted false claims about the election, or who directly pressured election officials or falsely accused them of corruption.

In addition to loyalists, Trump has also pardoned the well-connected and the well-heeled, such as:

- [Jonathan Braun](#), a drug smuggler and predatory lender, whose pardon was facilitated by Jared Kushner, the President's son-in-law. Doing so damaged a criminal investigation where the DOJ was hoping to get Braun to flip on other criminals. Once the pardon came, Braun had no reason to co-operate.
- [David Gentile](#) served about two weeks of his seven year prison sentence when Trump commuted his sentence. He was involved in a \$1.6 billion fraud of thousands of investors. The judge told Gentile that his crimes got him "a one-way ticket to jail." Little did he know that Trump was offering a one-way ticket out of jail.
- [Paul Walczak](#) stole over \$10 million of his employees' payroll taxes to fund a luxury lifestyle. When he was sentenced, the judge emphasized there "is not a get-out-of-jail-free card" for the rich. How wrong he was! Walczak's pardon application did not dwell on why he was innocent, but on his Mom. More specifically, that she had raised millions for Trump, that she had funded efforts to publicize Joe Biden's daughters drug problems. Weeks after she took the opportunity to join a "candlelit dinner" (cost: \$1 million) to dine with Trump, Walczak was pardoned, allowing him to skip jail and a \$4.4 million restitution.



Trump has been especially zealous in tilting the legal system to protect allies in the crypto industry. Trump once labeled crypto to be a "[scam](#)" that "can facilitate unlawful behavior, including drug trade and other illegal activity" but came to see the scam as an opportunity to

capture political allies and financial patrons. Trump and his family have netted billions in crypto holdings, partly by offering free passes to key figures in the industry. For example:

- Trump pardoned the former CEO of Binance, CZ Zhao of his money laundering crimes after Zhao and Binance promoted World Liberty Financial, the crypto company the Trump family has a stake in with its \$TRUMP coin. The SEC's fraud investigation into another crypto tycoon, Justin Sun, was paused after Sun spent tens of millions on \$TRUMP.

### **The Impunity Is the Point**

Trump is not waiting until the end of his term to issue questionable pardons. He is reveling in them. They signal impunity from the law for Trump's associates, and that the pardon store is open for business. Whatever loyalists do now that is likely illegal, they can hope for a pardon from Trump in the future.

In addition to the loyalists and wealthy supplicants, there is another category of pardonee: politicians who have been prosecuted for corruption. Twelve members of Congress accused of bribery or corruption have been pardoned, ten Republicans and two Democrats. But Democrats can also benefit. For example, Trump pardoned Henry Cuellar, the Texas Democratic Congressman, even before his trial began. Cuellar was indicted on accusations that he accepted \$600,000 from a foreign government and Mexican bank to influence US policy. Trump did not weigh in on the details of the case, merely claiming that Cuellar, like him, was the victim of a weaponized justice system. The net effect seems to be to decriminalize political corruption in America.

In justifying the pardon of former President Hernández, Trump said "They gave him 45 years because he was the president of the country — you could do this to any president on any country." Hernández, like others applicants, drew explicit connections with the prosecutions of Trump: "Just as you, President Trump, I have suffered political persecution, targeted by the Biden-Harris administration, not for any wrong-doing but for political reasons." Hernández's appeal was forwarded to Trump by another pardonee, and political fixer, Roger Stone. It is hard to miss the parallels between Trump's sense of grievance over prosecutions of his own misdeeds, and his willingness to exempt other politicians for their abuses of office.

Trump embraces his pardon power by also helping [celebrities](#). The more attention, the better. Pardon lawyers were told to recommend that Mel Gibson have his access to guns restored, despite a domestic violence record. Liz Oyer, the lawyer consulted, [said](#): “My recommendation was sought, I believe, to give a veneer of legitimacy to what was actually a political favor for a friend of the president. I said I couldn’t recommend restoration.” She was fired. When she was invited to testify in the Senate, only Democrats attended the hearing: “It has really perplexed me that there’s not a shared level of bipartisan concern about what’s happening inside the Department of Justice.”

### **A Broader Pattern of Abuse**

Trump’s pardon spree is part of a broader pattern of transforming the rule of law into rule by law. He is pardoning politicians who have been convicted of corruption, even as he is using the justice system to target political opponents. *For my friends, everything; for my enemies, the law.*

Not only did Trump pardon January 6 rioters, he directed the Department of Justice to stop prosecuting cases. One J6er whose case was subsequently dismissed correctly predicted: “President Trump’s going to be in office six months from now, so I’m not worried about it.” He was later [arrested](#) for aggravated kidnapping and sexual assault.

Not only has Trump pardoned crypto criminals, Trump has blocked several other investigations and enforcement actions into crypto donors and investors (see p21-23 of this report from Democrats on the [House Judiciary Committee](#)).

### **A Two-tier Pardon System**

The perception that Trump is handing out pardons is fueling a gold-rush. About [10,000 people](#) filed for pardons in the first nine months of the Trump presidency, which is about two-thirds of the total pardon applications for the entire four years of the Biden administration. The gold-rush benefits Trump, but also those in his orbit who have connections to a personalist regime. [Kenneth Vogel](#) of the *New York Times* has been covering this beat:

Lawyers and lobbyists with connections to Mr. Trump have scrambled to take advantage. They have collected large fees from clemency seekers who would not be eligible for second chances under apolitical [criteria](#) that are intended to guide a Justice Department system for



recommending mercy for those who have served their time or demonstrated remorse and a lower likelihood of recidivism. Instead, clemency petitioners are mostly circumventing that system, tailoring their pitches to the president by emphasizing their loyalty to him and echoing his claims of political persecution.

For example, a nursing home magnate who withheld \$38 million in payroll taxes was prosecuted by Trump's Justice Department, with Trump's former personal-lawyer-turned-US-Attorney Alina Habba claiming credit. After giving almost \$1 million to lobbyists, the magnate was out after three months of his three year sentence. The lobbyists in question, [Jack Burkman and Jacob Wohl](#), became infamous for their laundering of [conspiracy theories](#) during Trump's first term, and were subsequently convicted in multiple states for voter suppression efforts.

The clients who can buy their access to Trump's inner circle tend to be white collar criminals. White collar crimes are less shocking than violent crimes, but have real costs. For example, some of Gentile's victims lost their life savings. These crimes are also incredibly difficult to prove in court, even as the rich are able to fund a legal defense beyond the reach of ordinary people. Nevertheless, many might decide a good insurance policy is to put a down-payment on a pardon. After a wealthy fraudster served two weeks of a 42 month jail sentence, one DOJ prosecutor [said](#):

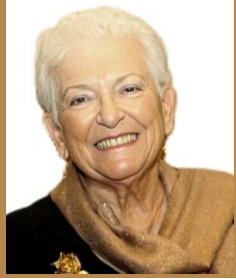
Afterward, defense attorneys are telling us they can't get their clients to take good or reasonable plea offers because they felt they're better off spending their money on a political donation, drawing Trump's attention, and getting the case dismissed or going to trial and getting a pardon.

The focus on the wealthy also robs victims and the public of restitution. One analysis by Democratic House Judiciary staffers found that Trump's pardons eliminated [\\$1.3 billion](#) in restitution and fines. It also reinforces the sense of a two-tier justice system. A lawyer for a pardon applicant [bemoaned](#) that his client had no chance even though he fit the DOJ criteria:

If you're just an average citizen, you can't even get in the line. I told my guy he'd probably be better off if he broke into the Capitol or made a major donation to Trump's inauguration.

# Letters From An American

“For the last couple of months, Senator Rumson has suggested that being president of this country was to a certain extent about character. And although I have not been willing to engage in his attacks on me, I’ve been here three years and three days. And I can tell you, without hesitation, being president of this country is entirely about character.”

In 1995 the late Rob Reiner— who, along with his wife Michele Singer Reiner, lost his life yesterday— directed *The American President*, written by Aaron Sorkin. In the film, President Andrew Shepherd, a widower, is facing a challenge from Republican presidential hopeful Senator Bob Rumson, who attacks Shepherd by focusing on the activist past of the woman he is dating, lawyer and lobbyist Sydney Ellen Wade.

The final scene of the film is a speech by the president rejecting the pretended patriotism of his partisan attacker, who is cynically manipulating voters to gain power. It is a meditation on what it means to be the president of the United States.

“For the record, yes, I am a card-carrying member of the ACLU,” Shepherd says to reporters at a press conference, “but the more important question is, why aren’t you, Bob? Now, this is an organization whose sole purpose is to defend the Bill of Rights, so it naturally begs the question, why would a senator, his party’s most powerful spokesman, and a candidate for president choose to reject upholding the Constitution?”

“America isn’t easy. America is advanced citizenship. You’ve got to want it bad, ‘cause it’s gonna put up a fight. It’s gonna say: You want free speech? Let’s see you acknowledge a man whose words make your blood boil, who’s standing center stage and advocating at the top of his lungs that which you would spend a lifetime opposing at the top of yours. You want to claim this land as a land of the free? Then the symbol of your country cannot just be a flag. The symbol also has to be one of its citizens exercising his right to burn that flag in protest. Now, show me that. Defend that, celebrate that in your classrooms. Then you can stand up and sing about the land of the free.”

“I’ve known Bob Rumson for years, and I’ve been operating under the assumption that the reason Bob devotes so much time and energy to shouting at the rain was that he simply didn’t get it. Well, I was wrong. Bob’s problem isn’t that he doesn’t get it. Bob’s problem is that he can’t sell it. We have serious problems to solve, and we need serious people to solve them. And whatever your particular problem is, I promise you, Bob Rumson is not the least bit interested in solving it. He is interested in two things, and two things only, making you afraid of it and telling you who’s to blame for it.

“That, ladies and gentlemen, is how you win elections.”

# Trump Says That You Are The Problem

Everything is perfect. Why aren't you grateful?

Last night Donald Trump gave [an important speech on the economy](#) in Pennsylvania — supposedly in a working-class area, although the actual venue was a luxury casino resort. The event was initially touted as the start of an “[affordability tour](#),” the first of a series of speeches intended to reverse Trump’s [cratering approval](#) on his handling of inflation and the economy. A number of news analyses suggested that he would use the occasion to blame Democrats for the economy’s troubles.

That was never going to happen. Trump did, of course, take many swipes at Joe Biden, as well as attacking immigrants, women and windmills. But to blame Democrats for the economy’s problems he would have to admit that the Trump economy *has* problems. And the speech was important because it revealed that he won’t make any such admission, and will continue to gaslight the public.

On Monday [Politico](#) interviewed Trump, asking him, among other things, what grade he would give the current economy. His answer: “A-plus-plus-plus-plus-plus-plus-plus.”

In fact, until very recently Trump wouldn’t even accept the reality that ordinary Americans don’t share his triumphalism. When Fox News’s Laura Ingraham asked him a month ago why people are anxious about the economy, Trump [replied](#)

I don’t know they are saying that. The polls are fake. We have the greatest economy we’ve ever had.

Since then Trump and his minions seem to have come around to admitting that Americans are, in fact, unhappy with the state of the economy. But if the economy is A+++++, why don’t people see it? The problem can’t possibly lie with him — so it must lie with you. “The American people don’t know how good they have it.”

I put that line in quotes because it isn’t a caricature or a paraphrase. It is, in fact, literally what [Scott Bessent](#), the Treasury secretary, said the other day:

We’ve made a lot of gains, but remember, we’ve got this embedded inflation from the Biden years, where mainstream media, whether it’s Greg Ip at the Wall Street Journal, toxic Paul Krugman at New York Times or former Vice Chair, Alan Blinder, all said it was a vibecession. **The American people don’t know how good they have it.**

Anyway, I may not be a political strategist, but I don’t think “You’re all a bunch of ingrates” is a winning message. It was, however, really the only message Trump could deliver, given his utter lack of empathy or humility.

At this point I could bombard you with a lot of data showing that the economy is not, in fact, A+++++. But it isn’t a disaster area, at least not yet. So why *are* Americans feeling so down? The main culprit is Trump himself.

First, during the 2024 campaign Trump [repeatedly promised](#) to bring consumer prices way down beginning on “day one.” We’re now 11 months in, prices are still rising, and voters who believed him feel, with reason, that they were lied to. Last night Trump insisted that prices are, in fact, coming way down. Again, “Who you gonna believe, me or your lying eyes?” is a self-destructive political strategy.

Second, Trump would be in much better political shape right now if he had basically continued Biden’s policies, with only a few cosmetic changes. When he took office inflation was on a declining trajectory. Consumer sentiment was [relatively favorable](#) at the start of 2025. Americans were still angry about high prices, but the inflation surge of 2021-3 had happened on Biden’s watch and was receding into the past. My guess is that many voters would have accepted Trump’s claims that high prices were Democrats’ fault and given him the benefit of the doubt about the economy’s future if he had simply done nothing drastic and left policies mostly as they were.

Instead, he brought chaos: Massive and [massively unpopular](#) tariffs, DOGE disruptions, masked ICE agents grabbing people off the street, saber-rattling and war crimes in the Caribbean. Many swing voters, I believe, supported Trump out of nostalgia for the relative calm that prevailed before Covid struck. They didn’t think they were voting for nonstop political PTSD.

And there’s more to come. Health insurance costs are [about to spike](#), because Republicans refuse to extend Biden-era subsidies. Inflation may pick up in the next few months as [retailers](#), who have so far absorbed much of the cost of Trump’s tariffs, begin passing them on to consumers.

So the “affordability tour” is off to a disastrous start. And it won’t get better, because while Trump insists that the problem is you, it’s actually him. And he isn’t going to change.



# What Happens When A Bonkers President Takes Over The Private Sector

We need independent regulatory agencies to contain him

What's really at stake in the fight between Netflix and Paramount for Warner Bros Discovery?

Let me make it clear I'm against Netflix acquiring Warner Bros Discovery. That would concentrate corporate power in ways that harm consumers and distort American politics.

But Paramount's acquisition of Warner Bros would be just as bad, if not worse.

What's at stake in all of this is Trump's — or any president's — power over the private sector of the American economy.

The back story here is that Warner Bros Discovery owns CNN, and Trump loathes CNN. He frequently complains that its coverage of him has been too negative. He's termed those running CNN "corrupt and incompetent" and has told top aides he wants new ownership of CNN, along with changes in CNN programming and personnel.

Last week, Trump [declared](#) he would involve himself in any proposed sale of Warner Bros, and on Wednesday he said it was "imperative" that the transaction result in the sale of CNN and replacement of its leadership.

Another part of the back story involves Larry Ellison — one of the richest people in America and the largest individual shareholder of Paramount, whose son runs it, and whose operation on Monday launched an unfriendly tender offer for Warner Bros Discovery, to counter Netflix's friendly offer.

Ellison is an ally of Trump. He has [assured](#) Trump and his top aides that if Paramount gains control of Warner Bros and CNN, it will get rid of CNN personnel whom Trump apparently detests, including Erin Burnett and Brianna Keilar. (Paramount already owns CBS.)

Paramount is portraying itself as the best bid for Warner Bros Discovery because it will have an easier time "getting regulatory approval" of the deal than will Netflix — even though Paramount is relying on financial backing from three Middle East sovereign-wealth funds (along with Jared Kushner).

Who in their right mind would give Middle East wealth funds *any* leverage over CBS and CNN? Answer: Trump, whose family business is already deeply dependent on financing from the Middle East.

Trump trusts the Ellisons because they pushed Paramount to settle Trump's frivolous \$16 million lawsuit against CBS and cancel Stephen Colbert — much to Trump's delight.

Trump loyalist flak Brendan Carr, the chairman of the Federal Communications Commission, then promptly [approved](#) the \$8 billion merger of Paramount with Skydance Media.

Trump's alliance with Larry Ellison goes back to 2020, when Ellison hosted a fundraiser for Trump at his home. According to court records, after the 2020 election, Ellison participated in a phone call to discuss how Trump's defeat could [be contested](#). In June 2025, he and his firm, Oracle, were co-sponsors of Trump's military parade in Washington.

Now in charge of Paramount and its CBS division, Larry's son, David Ellison, has [gutted](#) DEI policies at CBS, [put](#) right-wing hack Kenneth R. Weinstein into a new "ombudsman" role there, and made anti-"woke" opinion journalist Bari Weiss editor-in-chief of CBS News, despite her lack of experience in either broadcasting or newsrooms.

The FCC's Carr has already effectively blessed the Paramount deal. What other "regulatory approval" might be needed? Theoretically, the Federal Trade Commission could object on antitrust grounds. But, as Trump did at the FCC, he planted loyalists at the FTC to do his bidding. (Pam Bondi has asserted that she and the Justice Department's anti-trust division will oversee the merger.)

This past week, the Supreme Court heard arguments about whether Trump had a right to fire an FTC commissioner (the FTC, like the FCC, is supposed to be an "independent" regulatory agency).

Chief Justice John Roberts — who believes that the framers of the Constitution intended a "unitary" executive rather than one whose authority might be shared with independent regulatory agencies established by Congress — suggested during the oral argument that Trump's removal power should be the norm.

But if Trump's maneuvers over Warner Bros Discovery has any lessons for the future, the independence of regulatory agencies may be more important than ever before. Otherwise, a wannabe tyrant sitting in the Oval Office can interfere in any business transaction he wishes, to enlarge his own power and stifle criticism

# Silent Invasion: How To Fight Back Against Data Centers In Our Communities

Americans are NOT powerless from fighting back against Big Tech's unchecked growth and profiteering.

We are rightfully consumed by the urgent fights against corruption and threats to our democracy. But right now, at great pace, another immediate crisis is unfolding right under our noses: **the silent invasion of massive data and AI centers in communities all over the country.**

These digital fortresses, fueled by the insatiable demands of Big Tech and consumers, are devouring our public resources, eroding our tax base, and leaving behind a wake of environmental and social costs that local residents are left to bear. The truth is stark: while these tech giants promise progress, they deliver peril. ## The Hidden Costs: From Water Wars to Noise Pollution

The allure of “tech investment” often masks the devastating realities of what these facilities truly demand.

- **Draining Our Lifelines:** Data centers are voracious consumers of water, often siphoning millions of gallons daily for cooling systems. In regions already grappling with drought, this creates a cruel irony: residents face mandatory water restrictions while multi-billion-dollar corporations operate without constraint, leveraging precious public resources for private profit.
- **Straining Our Grid, Polluting Our Air:** A single large data center can demand as much electricity as a small city. This monumental energy pull strains local power grids, often necessitating new, costly infrastructure like substations, and frequently increasing our reliance on dirty energy sources to keep servers running. And let’s not forget the constant, low hum of massive cooling towers—noise pollution that erodes the peace and quiet of nearby homes. Residents can hear it.
- **A Raw Deal for Taxpayers:** State and local governments routinely offer colossal tax breaks, property tax abatements, and sales tax exemptions that can last for a decade or more. This means the very communities hosting these resource-intensive behemoths lose out on critical revenue for schools, roads, and emergency services.
- **Jobs Mirage:** The promise of local jobs from data centers is a mirage, not a reality. While construction offers temporary work, an operational data center typically employs **fewer than 50 people**. This is a dismal return on the massive public investment made through tax incentives and

subsidies. Worse, the few permanent positions—often low-wage maintenance and grounds-keeping jobs—fall far short of the promised living-wage opportunities for the community.

### **The Power Imbalance: Political Collusion and Corporate Conquest**

The unchecked spread of data centers is not accidental; it's the result of a systemic imbalance of power and **direct collusion between Big Tech and the Trump Administration/Republicans.**

The goal is simple: **deregulation and aggressive use of tax policy** to ensure massive companies can build infrastructure quickly and at minimal cost, at the expense of the American people.

- **Federal Regulatory Sabotage:** The administration has issued Executive Orders aimed at fundamentally reshaping the regulatory landscape. These orders **streamline environmental reviews (NEPA)**, expand expedited permitting for large infrastructure projects (FAST-41), and instruct agencies to **limit or waive key regulations** under the Clean Air Act and Clean Water Act (Section 404 permits).
- **Massive Taxpayer Subsidies:** Aligned with federal policy, Republican-led statehouses aggressively compete by passing laws that grant **100% sales tax exemptions** on equipment (servers, cooling gear) and offer long-term property tax abatements, sometimes extended until 2050 or later. This is often the costliest state subsidy, shifting financial burdens onto communities—US!
- **Direct Financial Incentives:** Federal initiatives directed by the Commerce Department are funneling financial support—including loans, grants, and tax incentives—to “Qualifying Projects” with minimal environmental oversight, provided the companies commit vast capital expenditures.
- **Government Secrecy:** Negotiations involving state incentives often rely on Non-Disclosure Agreements (NDAs), preventing local officials from disclosing crucial details (like water or energy usage projections) until the project is approved.
